# Levy amendment referendum now open

Over the last few months we have been talking to all our growers about the amendment we are required to make to the summerfruit Levy Order wording. You will recall that we need to make this change to ensure all growers are paying the levy equitably. It is in everyone's interest that the current inconsistency is cleared up and your vote to support the proposed change will achieve that. Voting is open from 19 October until 9 November, and you can vote either online or by using the postal pack you will receive. Voting YES in this referendum will give us your support to submit an application to amend the Levy Order wording. Please take the time to do so before 9 November. <u>Click here to vote</u>.
